



New BESS Unit Standard

Just one Crane Association member has met the requirements to train and assess the new Unit Standard 23436 under Bridge Engineering - Self Supervision

Our sole qualified member, C.I.T.A. Training, based in Alexandra, is also one of only two assessors in the entire South Island to offer the course.

Unlike the previous BESS Certification the new programme requires refresher training every five years to keep the Unit Standard up to date and all staff who hold the current BESS qualification will need to pass the new standard in the next 2 years.

Danny Stephen from C.I.T.A. Training says "...along with the traditional crane training that the company is known for, there has been additional pressure from operators to provide a 'complete package' when it comes to training so this is why we have diversified into the BESS Unit Standard and also Transit approved traffic management training."

Bridge Engineering Self Supervision (BESS)

Setting a New Standard

A new system has begun for drivers wanting to gain the BESS registration for overweight loads over bridges.

Each new or existing driver will need to gain Unit Standard (23436) as part of the process. All current holders have around 2 years to gain the Unit Standard, and will remain current until that time.

In addition, in the near future the NZ Transport Agency will issue a registration card to certify that you are currently BESS registered.

Steps for New BESS Drivers

1 The Driver applies through the Overweight Permit Officers at the New Zealand Transport Agency (NZTA) Regional Offices for registration (formerly Transit New Zealand).

2 NZTA processes your application and runs the background check required on the driver and company (if required).

3 The driver undergoes training and assessment against unit standard 23436 (BESS). Contact Tranzqual on 0800 4Quals (0800 478257) or visit their website for details of assessors available in your area.

4 Once the driver has been awarded the unit standard, your company can inform NZTA and the driver can be issued with provisional BESS registration (for six months).

5 If no breaches occur during the six months, full registration can be awarded (for five years).

Steps for Current BESS Registered Drivers

1 The driver undergoes training and assessment against unit standard 23436 (BESS). Contact Tranzqual on 0800 4Quals (0800 478257) or visit their website for details of assessors available in your area.

2 Once the driver has been awarded the unit standard, your company informs NZTA and your driver can be reissued with full registration for five years.

In order to gain the Unit Standard, candidates will need to register with NZQA, and they should also consider whether they wish to undertake any other Unit Standard-based training and assessment.

Land Transport Changes Rules

Despite little response when we sought members' views on changes to some Land Transport Rules, we had sufficient data to make submissions on:

- Drivers licensing – remove requirement for operators to hold a "w" endorsement to drive an all terrain crane
- Logbooks – rule to include exemption for crane operators rather than companies having to apply.

Making submissions - our chance to influence policy.

Codes of Practice

The Code of Practice for Cranes is in its final stages of amendment and council would like to record thanks to the review committee and in particular the Chairman (John Carter) and the willingness of the Department of Labour through the efforts of Andrew Kear to ensure that what comes out for comment before the Minister signs it off is the best that we can come up with.
